**General Park Information:**

**Rabies Warning:** Rabies is on the rise in New York State. Please do not feed, or harass raccoons or any wildlife while visiting the Park. Put all food and garbage in secure, sealed containers. If you should notice any wildlife behaving in a strange manner or appearing ill, contact park officials immediately. Report any bites, scratches or other contact with a wild or domestic animal to park officials immediately.

**Pets:** Pets are **NOT** allowed in the park, there are no exceptions.

**Alcohol:** Alcohol is not permitted in the park.

**Swimming:** Swimming is permitted at the designated area during beach hours only. Underwater swimming apparatus, inner tubes, beach balls, etc. are prohibited. Alcoholic beverages and glass containers of any kind are not permitted on the beach.

**Fires:** Open fires are not permitted in the park. Grills are provided for cooking.

**Firearms:** Firearms are not permitted in the Park.

**Fireworks:** Fireworks are illegal in New York State.
