Zoning Map Draft-Consolidated Map for all districts

Hamlet of Constantia-moving the existing residential areas by extending to area between Recreational trail South to 49 to Town line along Lower Rd.

Motion by Joe Markham to extend existing residential area in Constantia to above area. Seconded by Randy West. Motion passed unanimously.

Graphics to begin to be added to the draft map to clearly define all areas of *Proposed* Residential, Rural, Industrial, and Waterfront Zones.
