### **Approval of Minutes**

## **Mosley Subdivision**

# Preliminary Site Plan Review, Shore Campgrounds

Parmley Dr., Parcel id: 310-07-04-02. Needs to submit site plan as previous site plan was submitted under a different tax map id. Original 1988 map had a different tax map #. Unknown when property subdivided. Previously requested changes only needed DOH approval at that time. Causing confusion with Parcel id.

Mr. Dolan presented that property owner would like to build two cabins in a space that a mobile home was located in. The mobile home has been removed while the septic and water remain available in that space. Currently the remaining property has RV's as a campground and falls under the "campground law". The owner would like to build two 20'x40' cabins next to one another.

Mr. Peck presented that the site plan states these are two RV sites in this space. Owner has always stated RV sites. A change to the site plan from RV sites to buildable cabins requires a new site plan for review. More research will need to be done with this change to the site plan as there are different land use laws for RV's vs. cabins.

This Board will need a new site plan in writing before moving forward. Property owner was invited, but not in attendance at this meeting.
