# **Approval of Minutes**

# **Zoning Discussion**

Zoning District draft definitions page and Town Zoning Map Review. A map was displayed, supplied and prepared by Matt Johnson of the Tug Hill Commission and input from previous meetings with Board members indicating commercial, waterfront, and industrial zones in the hamlet areas of Constantia and Bernhard's Bay.

Zoning district definitions page handed out for review detailing more extensively Waterfront, Industrial/Commercial, Residential, and Rural approved zoning district draft definitions. Along with current concept map members discussed finalizing zoning lines in each hamlet. Leaving the option open to creating additional zones for further definition to encourage business development and entrepreneurship.

Referencing the matrix chart discussed at previous meetings and how the draft of definitions page, as handed out, fits into the matrix chart. Members had extensive discussion regarding what constitutes a home based business and small business vs. industrial to maintain the character of the towns and what could and should be allowable. The zoning district definitions indicate potential allowed uses, site plan review required, and/or special use permit required for each of several possible land uses. Wanting to keep the rural community feel

of the town but not limiting traditional retail spaces in the area. Allowing businesses to thrive and not limiting our ability to grow while still maintaining a rural community. Leaving open room for the future if the trend of the town is in a different direction.

MOTION to accept Town wide map of Zoning and definitions by Mr. Godzwin, seconded by Mr. West. Motion carried unanimously.
