In the letter Ms. Mark is requesting the lot to be unserviceable for both water and sewer, this lot is the last one on 29th St. After discussion, with the location of the property and the letter requesting it be declared unserviceable, Mr. Tomaino made the motion to accept Ms. Marks request for 310.05-02-01 be deemed unserviceable for both water and sewer, seconded by Mr. Chapman.

EDU SCHEDULE:

With no change suggested for the EDU Schedule from 2024 Mr. Tomaino made the motion to approve the current EDU Schedule with no changes, seconded by Mr. Pone.

WASTEWATER-IMA:

Discussion on the Intermunicipal Agreement (IMA) with the County on the SOCRIS project. This IMA needs to be signed by all parties by September 11th for it to be included in the grant opportunities for the County. Mr. Moran is concerned that if SOCRIS receives funding, but Constantia does not, what will happen, will the District still be responsible for the EDUs as stated. As with anything, it is a possibility that the North Shore Sewer District will not be funded, but SOCRIS is the best alternative to constructing our own plant. All agree there are lots of unknown, but the Town needs to continue to move forward. With no more discussion:

Mr. Whitney told the board this is the same grapple they have been borrowing from West Monroe, a new one is \$11,797. Mr. Whitney would like to take advantage of this offer. Board members present agree this will be a good purchase for the Town. Mr. Whitney had board members sign a voucher for Ms. Butler.

AUDIT:

Mr. Chapman brought up the audit results, Mr. Moran is very happy with the results as is Mr. Chapman. Mr. Chapman and Mr. Moran had a long conversation with Mr. Petrie after the audit. Mr. Petrie has some concerns as to our fund reserves. Mr. Tomaino responded that he believes this conversation needs to be had with Ms. Butler, all agreed.
